Schools, colleges and universities generally contain much IT equipment, and as the premises are used by many people, safe storage is of prime importance. The equipment must, however, be ready for use at all times. Blika has therefore designed a storage locker with battery charging facilities for laptop computers and other mobile electronic equipment. Built-in power sockets allow the equipment to be charged during storage. An intelligent storage system, which can be used to store equipment owned by the school or college or by the pupils and students themselves.

Each box contains power sockets that meets the latest requirements and there is plenty of room for laptop computer, mobile phone, tablet and a small bag. The reinforced single-walled doors are equipped with sturdy door stops. Lockers are available with flat or sloping tops and can be equipped with a variety of locks.


